1. Why are you interested in serving on City Council?

I love our city. My partner and I are investing all we have here and intend to always live here. As a result, I have a concern for the welfare of Harrisburg and its citizens. I believe I can help the council to achieve its goals and to have a more trusting and open relationship with the Mayor. I am not interested in politics, I am not a seeker of power or wealth. I have removed myself from the private sector and from working with financial capitol, and my energies have turned toward increasing the use of social capitol in the public domain. Although I am not interested in a career in politics, I have become interested in the city government this last year and I am interested in helping to facilitate dialogue between the branches and in developing a strong bridge of communication between the Mayor and the City Council. I have reason to believe that, although we have only had brief occasion to speak, the Mayor has a grasp of my neutrality and good intentions, knows I carry no agenda or personal aspirations for power, and properly perceives that I work always for the good of our city and its citizens. I have seen that the Mayor and Council members seem more willing, or more able, to discuss their frustrations and concerns with media than with one another. I perceive a lot of room to negotiate, that there is still a lot of space to create agreement from what appears to have begun as a struggle for power - based on unspoken and unrecognized assumptions that are implicit in the actions and comments of both branches. The struggle to retain power comes from lack of trust in sharing power. Rather than creating a basis for contention, I understand this to be a contrived space open, therefore, to compromise and even evolution. I want to offer my services and skills in facilitating dialogue to the city for the remaining months of the open chair, with the intention to leave bridges for communication and useful tools for resolution behind that will continue to assist the city government as they move forward with the new administration.

2. In your opinion, what is City Council's primary function in the Optional Third Class City, Mayor-Council Plan A form of government? The strong mayoral form of government requires an especially wise and diligent legislative branch. As a balance to the executive branch, and as check to its powers, the Council needs to be diligent in maintaining a gestalt vision. , As the letter of the law requires the cooperation of the executive and legislative branches, the offices must be interdependent and the branches must be willing to consult and advise and consent together in the important work of upholding and developing the laws and ordinances of our city and its contracts. Progress requires the branches, though they may be at odds with one another, to rise above the variances of politics and prove capable of reconciliation and openness to all possible negotiated agreements. It is my feeling that the spirit of the law requires the legislative branch to be responsible to advise the Mayor and in the position of counsel, needs to be responsible to open new avenues of communication and opportunities for trusting dialogue. The City Council must always stand as an advisory body, even responsible for opening and encouraging communication between branches. It is imperative for any advisors to be able to listen objectively, and to ask those critical questions that flesh out information from both sides of the debate. I am especially skilled in this area of dialogue, the ability to quickly form

As you know during much of my time in Harrisburg, I have been rehabbing, renovating,, and re-renting Houses. So since you probably have a million resumes to review, let's make this one FUN!

Educational and Athletic Leadership:

I was Junior Class President in High School, and was elected Student Body President my Senior year. I also qualified for the District track meet in pole vault. (There were about 8 guys in all of Lancaster County who cleared over 12 feet that year, and 4 were on my team. But of those 4, I was the only one to qualify for Districts,

You see Carville and Begala conjured up a Harris Wolford U.S. Senate win. (Wolford was than PA Secretary of Labor and Industry.)

Given my political interest, I might have helped the campaign. Carville and Begala next got Bill Clinton elected President. Life is full of potential possibilities.

Rendell Asks My Question:

I did play a small part in getting Gov. Ed Rendell elected. I had written an Op-Ed piece (not one I've included to you), which stated at the end "vote for the guy who has a plan to lower school property taxes".

Rendell had a meet and greet on City Island, and I gave him a copy of my article. And lo and behold, the next day the Patriot-News runs a picture of Rendell, with my article clearly

protruding from his shirt pocket.

But the best part was... (sidebar: Rendell managed his own campaigns) ...the best part was in the final debate for Governor, Rendell asks the GOP's Mike Fisher, "do you have a plan to lower school property taxes?" Fisher was tongue-tied.

By the way, Harrisburg is one of the few locations who have really benefited from that

casino based plan. Every year I pay about \$400 less in taxes.

I had promised to return to question 5 (of the application). In recent years I have not been much of a joiner of groups. I mean I have periodically donated to 3 food banks. I helped one neighbor remove a ceiling, and put shutters on a different neighbor's house. And of course I attended various forums on the city's debt crisis, and on school issues.

But what really motivates me, is solving a specific problem.

<u>I can't be that Old</u>: (Yikes, can I say that?) As Bob Dylan sing(s) in Maggie's Farm "she's 68, but she says she's 54". Well, I'm closer to 54.

Back in the day, I coordinated Special Events, in Lancaster County, for the "Vote Yes for Farmland Preservation Referendum". Well, I actually did much more than that! I convinced a very respected leading Farm spokesman to pull together a group of about 50 to promote the referendum. I suggested a lawyer whom I really respected, and the former owner of the Pennsylvania American Water Company (who sold it several years ago to a European consortium for Billions of dollars). But the farm spokesman knew many more people than me.

But as to my part in promotion, I had a big sign made which I displayed at events, and mounted it atop a rental car, and drove it through 2 parades (which are a big deal, in towns over there). And we had a stand at Park City Mall for about a week.

I also walked into the County Paper, said I wanted to promote the Referendum, and they plastered my words on 3 or 4 pages (along side an opponent). With all modesty - we killed them.

The Referendum won statewide. The way it works is either the state or county will pay a farmer the difference between what the land could be sold for as development vs. its price valve as farmland. In return the farmer (he or she) agrees to keep the land in agricultural production for either 25 years, or forever. The program has been a huge success. PA has preserved more farmland than any state in the nation.

I've found "the Word to be stronger than the Sword". While in Harrisburg, in addition to the Rendell story, I played a part in the Hershey Company not being swallowed by Wrigley's Gum.

Question #1 Why are you interested in serving on Council?

The Council seat is a form of public service. A form of public service not far removed from the various professional and volunteer positions I have participated in my whole adult life.

One of the most significant questions I ask myself before taking on any employment or volunteer service is whether or not I have the desire, time, and ability to fully commit and be effective in the role and responsibility I am considering. In the case of public service, having knowledge and understanding regarding the various roles of government officials and how the relationship of each position fits into the overall structure is an added condition, in my view.

I have taken the time to carefully consider my reasons for submitting my name to fill the Council Seat tragically left vacant by one of the most esteemed members of our community. The task of Councilperson is a daunting endeavor under ordinary circumstances, and taking on this role during a period of mourning, transition, and financial uncertainty adds to the difficulty of the position. However, as I look back at my years of service to the Nation and our community, I have confidence my abilities and level of commitment are of such a level that I can be an asset within the Council body in particular and the residents of the city as a whole.

Question #2 In your opinion, what is Council's primary function in the Optional Third Class City Mayor-Council Plan A form of Government?

As we all realize the City of Harrisburg is governed under the 3rd Class City Code, Option Mayor-Council form. Under that option, the Mayor (Executive Officer) and Council (Legislators) have certain outlined duties. For instance, the Mayor appoints Department Administrators who manage the day-to-day functions of the city, submits the annual budget, and carries out laws or ordinances passed by Council. The Council passes ordinances (laws) which the mayor must carry-out.

Questions and discordance regarding roles often arise when one or both arms of city government seemingly have over-lapping jurisdiction over legally binding duties or when the State law governing cities of the 3rd class are vague or non-existent regarding certain circumstances. Ideally, the relationship between the Mayor and the Council will be such that compromise, beneficial agreements, and collaboration will be the end result when differences in positions arise. In the small number of cases where stalemates are apparent, an evaluation of the roles and responsibilities of each office must be implemented by the person holding their individual seat. With that evaluation, it is incumbent upon each elected individual to understand the legal implications, public opinion, and short and/or long term consequences of their behaviors, reasoning abilities, and specific votes.

The role of the Council within a 3rd Class Optional code is, to a certain extent, fluid. That is to say, within the very limited roles and responsibilities written into the code pertaining to the office of the Mayor and Council, there is some room for flexibility which allows for collaborative efforts between the two branches of government. When the roles and responsibilities of each elected office are well understood and duties undertaken in "good faith" by all parties involved, the governance of the city is executed in a well-balanced, stable, and efficient manner. As such, in my view, the role of a Councilperson under the

Mayor-Council form of governance is to ensure that a climate of cooperation and respect for the tasks, duties, and respective responsibilities of each official is firmly established so that the true role of Government – service to the community – is undertaken so that the best interests of all citizens living, working, and recreating within the city is the deciding factor of any governmental action.

As a person that has dedicated my life to public service, I believe I have the skills and abilities to navigate, understand, and work within the structure of a Council seat. As a parent, I reconstituted the dormant PTA within my children's' school. I also ran, and was elected, to a School Board Seat. As an employee, I have spent decades working within budget and finance as well as the grant fields of government.
